




3. Only 1 CWSN toilet(boys or girls is not clear) is seen and that too without the accessories like supporting handles/hand rails, as prescribed under the RPwD Act. The school shall ensure construction of separate CWSN toilets for boys and girls as per norms on every floor. The school shall install hand rails along the ramp at the entrance of the building and submit compliance on these points within 3 months on SARAS portal.
4. The library and composite science lab shall be upgraded as per the SoPs issued by the Board and school shall submit compliance within 3 months on SARAS portal.
5. The class room walls are dirty and need improvement. The school shall get the class rooms whitewashed and doors and windows painted within 3 months. The school has reported no toilets for male and female staff, which is not as per norms. The school shall construct adequate number of toilets for male and female staff within 3 months. Compliance on these points shall be submitted on SARAS portal.
6. The school shall follow the SOPs issued by the Board in respect of labs, library and sports facilities.
7. The school shall ensure training of its teachers with CoE Bhopal, within 3 months and submit compliance on SARAS portal.
8. The school is required to renew all the mandatory certificates from time to time and directed not to remove the videography link in future.
